Draft Modules of PPWK for Elementary Students

In the cycle-1 grant, the West Papua Maritime Consortium (KMB PB) prepared 3 draft Modules for the Introduction of Maritime Program (PPWK) for Elementary School students.

In cycle-2, KMB Papua continued by consulting the final draft of the PPWK modules with teacher representatives from 10 elementary schools in Kaimana. The modules are (1) "Introduction to Ecosystems, Marine Biota and Marine Forms" for grade III students, (2) "Conservation & Utilization

of Marine Biota" for grade IV students, and (3) "Maritime Nation & Wealth of Indonesian Marine Resources" for grade V students.

The consultation workshop took place on **August 2, 2019** in Manokwari and also attended by representatives of the DKP PB, CII, EcoNusa Foundation, WWF, and FPIK UNIPA.
